Alcoa, Government asked to resolve compensation issue

A move by Southwest Greens MLC Paul Llewellyn to send Alcoa and the Government back to the drawing board over community compensation claims for residents impacted by the Wagerup alumina refinery has failed to gain support in Parliament.

“The Legislative Council has the power to reject Alcoa’s expansion agreement, forcing the company to the negotiating table.” Mr Llewellyn said. “Due to lack of support from the Government and the Opposition, the people around Alcoa have now been left stranded and are facing financial hardship.”

South West Liberal MLC’s Robyn McSweeney, Barry House and Nigel Hallett moved for an Inquiry to be conducted by the Standing Committee on Environment and Public Affairs into the fairness of the compensation process, including the Supplementary Property Purchase Program (SPPP). “While such a move does have merits, it’s a weak-willed response to the situation,” stated Mr Llewellyn.

According to Mr Llewellyn, “We’ve been steadily working with the local community and government to try and gain fair and adequate compensation for those affected. Over the years Alcoa’s compensation schemes have become less and less generous with this latest offering being a ‘take it or leave it’ valuation with no funding to cover moving costs and a very tight time frame for making a decision. Alcoa’s terms demanded that those wishing to move on had to sell, fund the move themselves and find a replacement home within 7 months.

“Offering compensation is acknowledgement by the government and Alcoa that people need to move due to health reasons brought about by Alcoa’s pollution. To offer a scheme that puts these people under financial and emotional pressure is unfair and unjust.

“I attempted in Parliament to call the Government and Alcoa into account over the unfair structure of this latest compensation. I wasn’t calling for a halt to Alcoa’s expansion or for tighter environmental controls, but that they take proper financial responsibility for their impact on those living nearby.

“Due to lack of support from the Government and the Opposition the people around Alcoa have now been left stranded and facing financial hardship. ...This was a real opportunity for Parliament to show leadership but the Government and the Opposition have put big business ahead of community protection,” said Mr Llewellyn.

The Legislative Council has called for Alcoa and the Government to resolve the issue before 14th of August. To ensure that the matter is dealt with accordingly, a petition to the Legislative Council is currently circulating in Yarloop, calling “for the Standing Committee on Environment and Public Affairs to enquire into the fairness and just terms of Alcoa’s compensation arrangements, including the SPPP, with particular reference to the financial impacts and hardship experienced by the affected landholders and that the committee report back no later than 30th November 2007.”

DEC's preliminary LIDAR report supports community complaints

An interim report by Arizona State University researchers, working in conjunction with the DEC, stated that the Lidar tests around Yarloop in 2006 detected “persistent, low-level (i.e. low height) refinery plumes occurring under stable atmospheric conditions...especially during winter.” The study found that the plumes extended “over distances of 3 to 5 km from the refinery” and that the plumes remained “for up to 18 hours...Both the ASU and NOAA (*US National Oceanic and Atmospheric Administration*) highlighted the possibility that meteorological conditions in the Wagerup region could bring plumes down to the ground level.”

The report indicated that “the Lidar also detected numerous dust emissions from the Residue Drying Areas...mainly short-lived puffs, several plumes up to two kilometres long and persisting for up to half an hour.”

The Power Point presentation at the DEC community meetings in June showed a time-lapse representation of the Lidar tracking plumes from the refinery and RDA, also indicating where a canister was taken while the plume passed by. For a canister to be taken, an odour must be noticed at ground level, confirming that the plumes do, indeed, reach the ground.

John Sutton, manager of the Air Quality Management Branch of the DEC, stated that these findings warrant further investigation, including more research into the particulate matter onto which chemicals may adhere.

Because current air quality standards are based on industrial exposure and not long-term, low-level exposure as residents may experience, there is reason to question the viability of these standards in determining what is actually “safe” for communities in close proximity to industrial sites.

The actual findings and discussion with the DEC representatives were in sharp contrast to media stories on the ABC and GWN following the release of the Lidar report, which stated that the DEC had assured residents that they should not be worried about air quality near Wagerup.

Pollution Logs are vital documents!

Please use these logs to keep track of odour and health events associated with Alcoa emissions. Completed log sheets can be dropped off at the Yarloop General Store.

These logs assist CAPS in comparing dates, times and nature of odour and health complaints with other information we receive. If you also possess a DEC Wagerup Community Air Sampling Program Observation Log Book, we recommend that you keep that up to date.

Since 15 February 2006, 38 events have been noted on Yarloop Bucket Brigade log sheets by local residents. However, we have heard many more complaints from residents that weren't recorded. Please help us document proof of the impact Alcoa has on this community!

Rising community concerns regarding the ongoing adverse impact on the environment and community health from industrial pollution within Australia has led to the formation of community-based group AIR CARE AUSTRALIA- an initiative of the *Australian National Bucket Brigade*.

Denny Larson, executive director of *Global Community Monitor* and program director Ruth Breech were back in Australia to facilitate the “*National Bucket Brigade Training*” in West Perth, 2-3 June, organized by CAPS.

The “National Bucket Brigade Training” involved community participants from Kwinana Progress Group, Midland Frogs, Alliance for a Clean Environment, Townsville Bucket Brigade, Locals for Esperance Development, Canning Melville Community Odour Action Group, Geelong Community for Good Life, and Community Alliance for Positive Solutions Inc. (CAPS, Yarloop).

The training was sponsored by the Department of Environment and Conservation (WA), South West Catchment Council, Greens WA and the Australian Greens, Harvey Fresh, Harvey IGA, Harvey Cheese, and Mimmi's Quality Fruit and Veg.
